

STATUTORY PROPOSAL FOR PRESCRIBED ALTERATION TO BRADY PRIMARY SCHOOL

The establishment of the nursery will be implemented from September 2019.

3. Alteration description

A description of the proposed alteration and in the case of special school proposals, a description of the current special needs provision.

A temporary unit will be installed to accommodate the nursery pupils for September 2019. The permanent nursery will be post built and integrated into the main school building as part of the proposed construction and refurbishment.

The main bulk of the proposed extension is a single storey flat roof classroom extension to rear of school, to provide 8 number additional classroom spaces with

associated intervention rooms, toilet facilities, office accommodation, stores, boiler room and circulation space.

The remaining extension will be a single storey flat roof infill studio extension to school hall.

A re-provision of the existing car park and the area of the existing staff parking is to be re designated as a non-vehicle/ pedestrian area to improve the flow of parents and children around the exterior of the school.

A further section of the acquired land will be re-surfaced and used as additional playground area to compensate for the area of playground lost to the extension.

The remainder of the acquired land is to be prepared and seeded and used as playing field.

The existing permanent capacity of Brady Primary is 202.

The proposed permanent capacity after the alteration will be 420.

The number of children currently admitted to Reception at Brady Primary School is 30; the proposed number from September 2020 will be 60.

Brady primary school currently has 205 children on roll.

Objectives

The objectives of the proposals.

The expansion Brady from one form to two forms of entry will bring an improved assurance on financial viability and an opportunity to improve the existing school which is in a poor state of repair and requires considerable amount of work such as renewal of the lighting, power installations, heating, hot/cold water pipework and total refurbishment & redecorations throughout.

Another objective of the proposal is to provide much needed additional school places in the Rainham and South Hornchurch planning area by enlarging the premises of Brady primary school from September 2020 in response to an increasing demand for school places. In Havering we have seen an increase of 52% in the number of births between calendar years 2002 to 2016. This includes a 19% increase in the birth rate from 2012 to 2016.

There is considerable housing growth planned for Havering with the Rainham housing zone to provide about 3500 new homes. In addition to this, there is also a regeneration scheme of some Council estates in the area for about 200 new homes. These additional new homes will result in a continuation and probable escalation of the projected increase in pupil numbers. Therefore, the Council must find ways to provide more school places for local families over the coming years.

Consultation involved publishing pre-statutory consultation document on the school & Council's website, setting out the reasons for the proposals and how comments could be made. This was issued via email to all stakeholders and a including all parents/carers and staff of Brady Primary school. This document also invited 'online' participation through the use of 'survey monkey'. A consultation meeting was held 18 December 2017. The analysis of responses received during the consultation period is as detailed in the consultation feedback

report. Provision has been made within the 2017/2018 school expansion Capital Programme to meet the cost of expansion and also a significant investment of Condition Grant funding.

Early years provision

The proposal seeks to change the lower the age range of the school from 4 to 11 years old to 2 to 11 years old. The proposed change will enable the establishment of a nursery; thereby making provision for 30 FTE 3 & 4 year old places to be admitted into the school's nursery.

how the school will integrate the early years provision with childcare services and how the proposals are consistent with the integration of early years provision for childcare;

The recent Ofsted inspection of the early years provision in the school is good. It noted that the leadership and management of reception is outstanding and that transition into Reception is well managed and planned so children are quick to settle and make progress in their learning. Therefore, a new nursery provision at this school would benefit from the already outstanding practice in the early years provision at this school.

evidence of parental demand for additional provision of early years provision;

Brady is located in the Rainham & Wennington ward and the Havering's Childcare Sufficiency Report identifies a deficit of funded 3 & 4 year old places in this ward. As part of the pre-statutory consultation undertaken during the period from 4 December 2017 to 15 January 2018 for the nursery establishment, 7 respondents

supported the proposal to establish a maintained nursery to enable the school to deliver early years and childcare provision.

The establishment of a maintained nursery in this school will help meet parental demand for quality funded early years places in the local area.

There are 5 private childcare providers and 1 maintained nursery school establishment offering sessional care with the exception of 1 private provider offering a full day care within 3mile radius of the school. The Rainham and Beam Park Strategic Development Area is anticipated to deliver over 3,000 homes. Delivery is due to start from 2018-19 onwards. The projected child yield from this housing growth has been factored in the school roll projections. In the long term, this is likely to result in a continuation and probable escalation of the projected increase in pupil numbers.

With the sustained and increasing demand of school places, a further permanent expansion in this area is required.
